The purpose of this memorandum is to provide notice of changes that are being made to the National Remedy Review Board (NRRB) review threshold. Effective July 1, 2005, the NRRB will review proposed cleanup plans for both National Priorities List (NPL) and non-NPL Superfund sites where costs for the preferred action are estimated to exceed twenty-five million dollars, which is a revision from the current standard of thirty million dollars.

EPA announced the deletion of the Firestone Tire and Rubber Company Superfund Site from the NPL. The effective date of this rulemaking is April 21, 2005.
