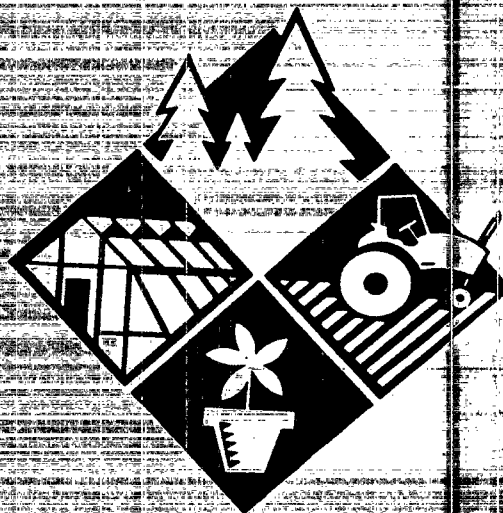
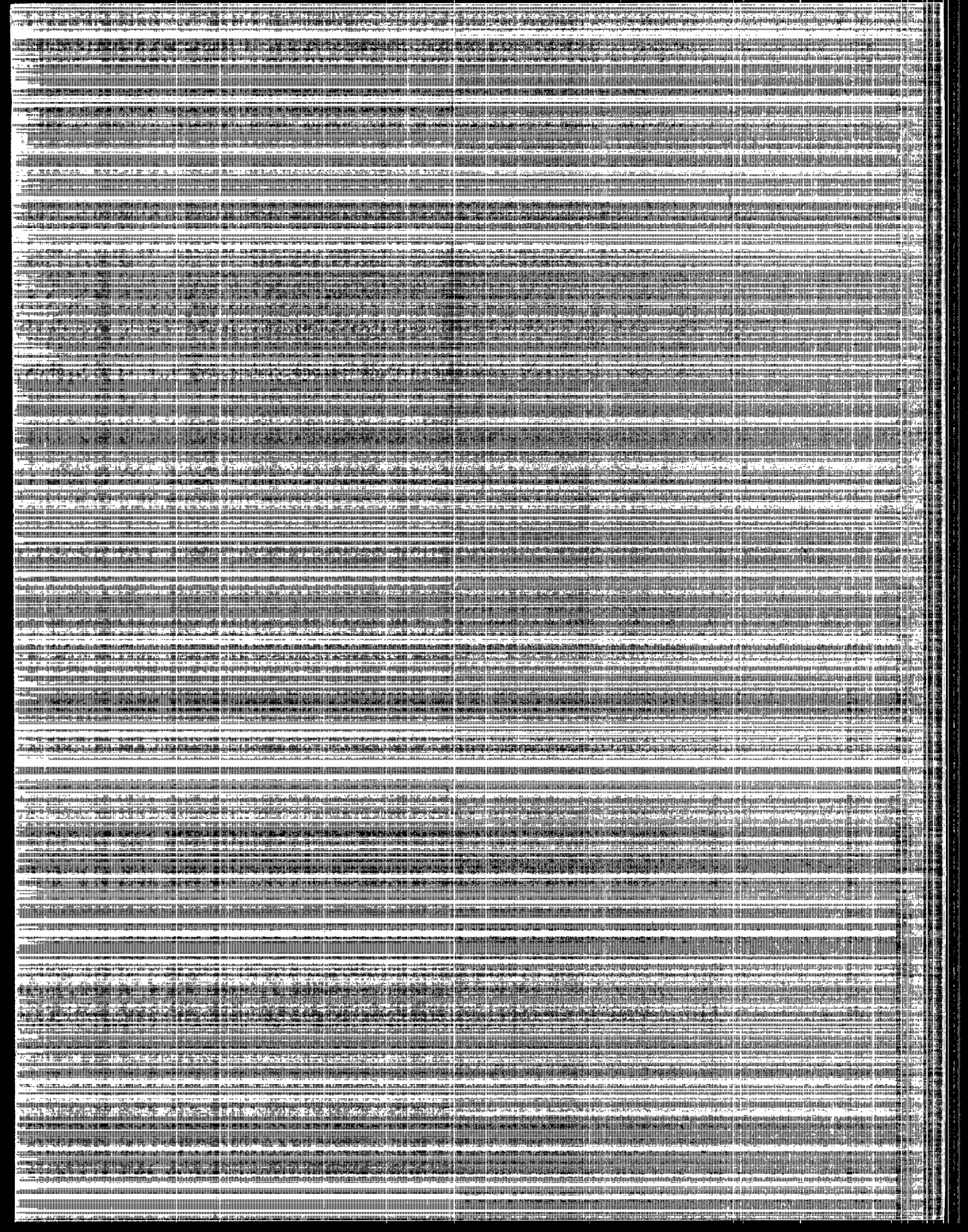

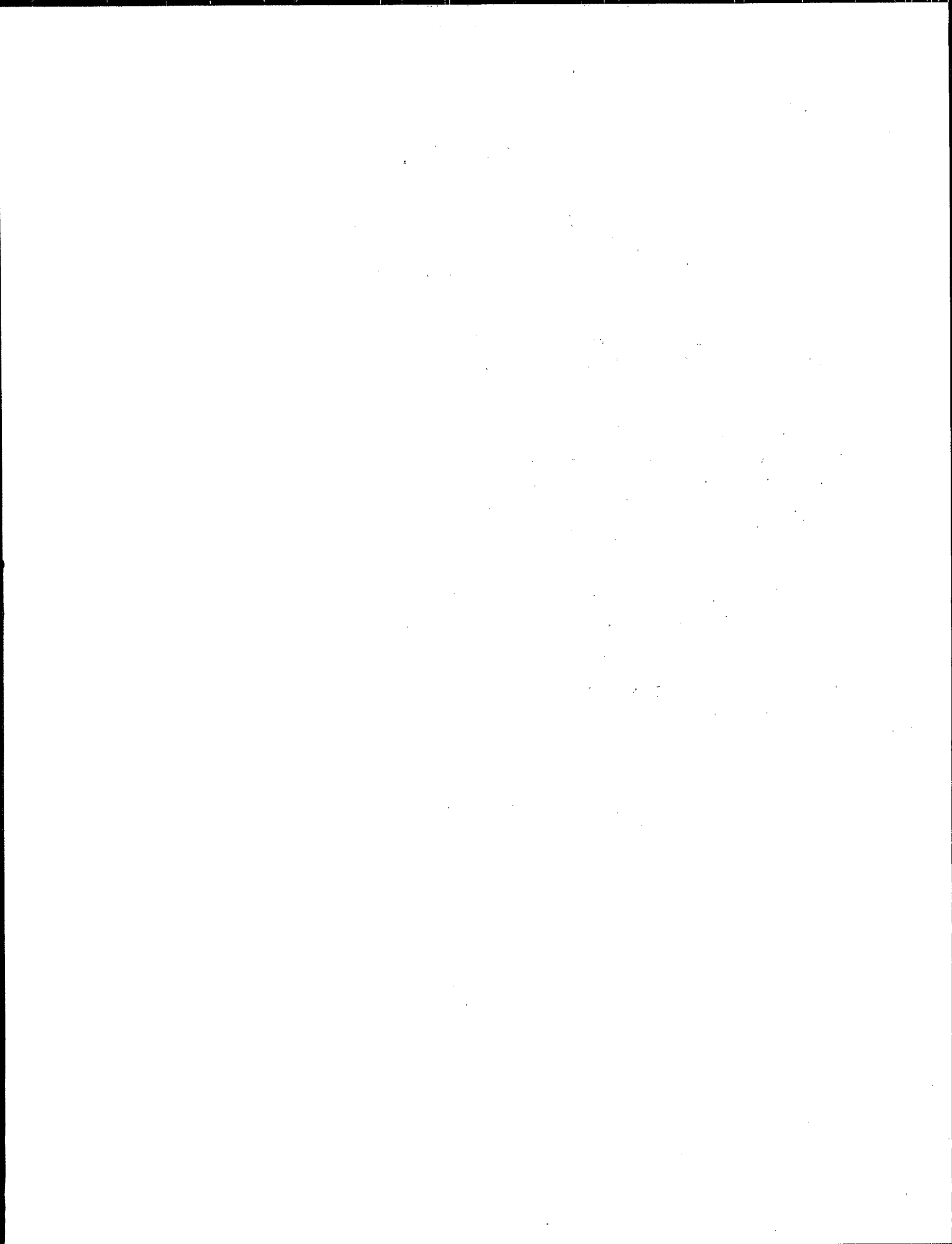
This listing identifies pesticide safety, training and informational materials that were developed or produced by the Environmental Protection Agency (EPA), States, and other establishments, organizations or associations.

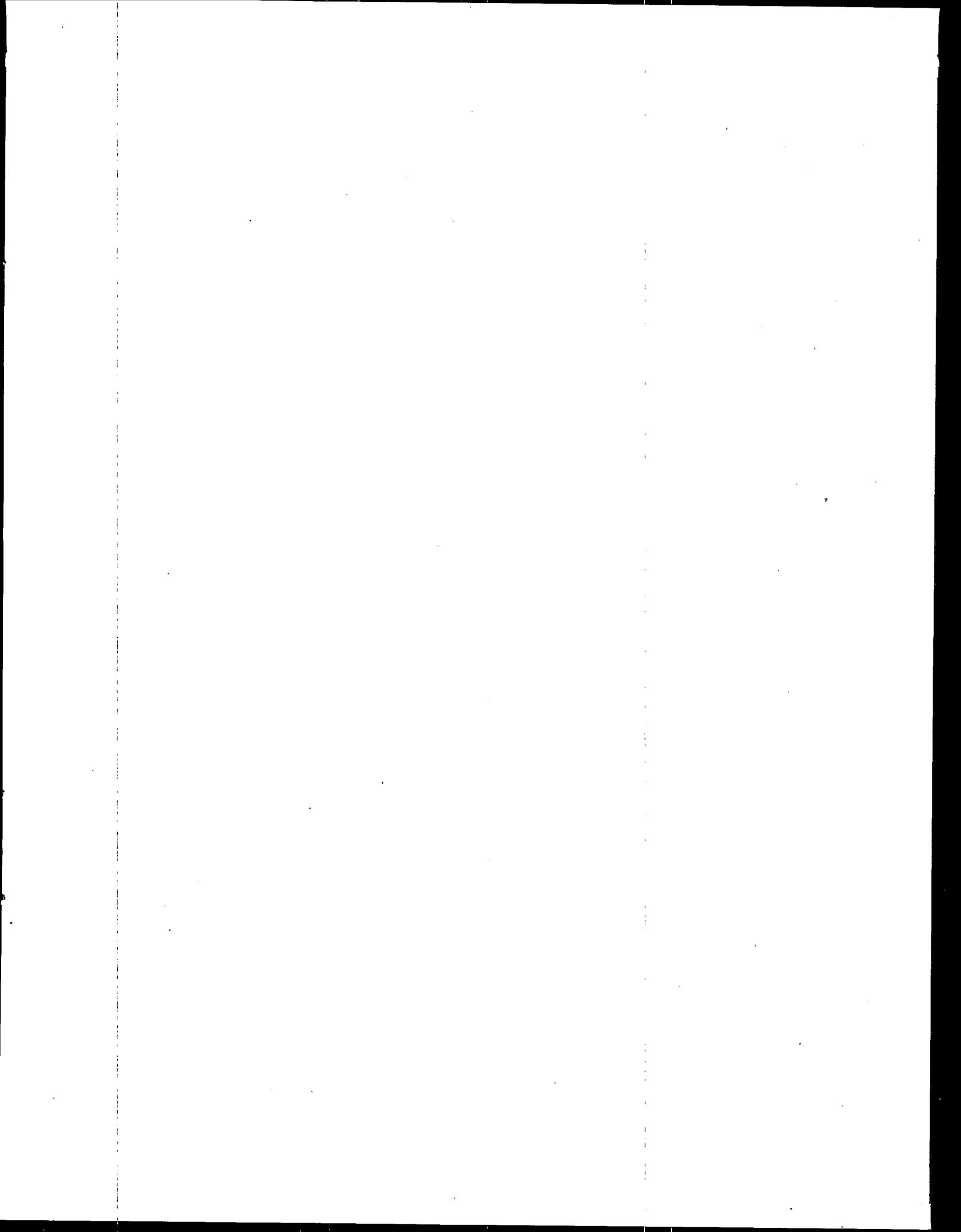

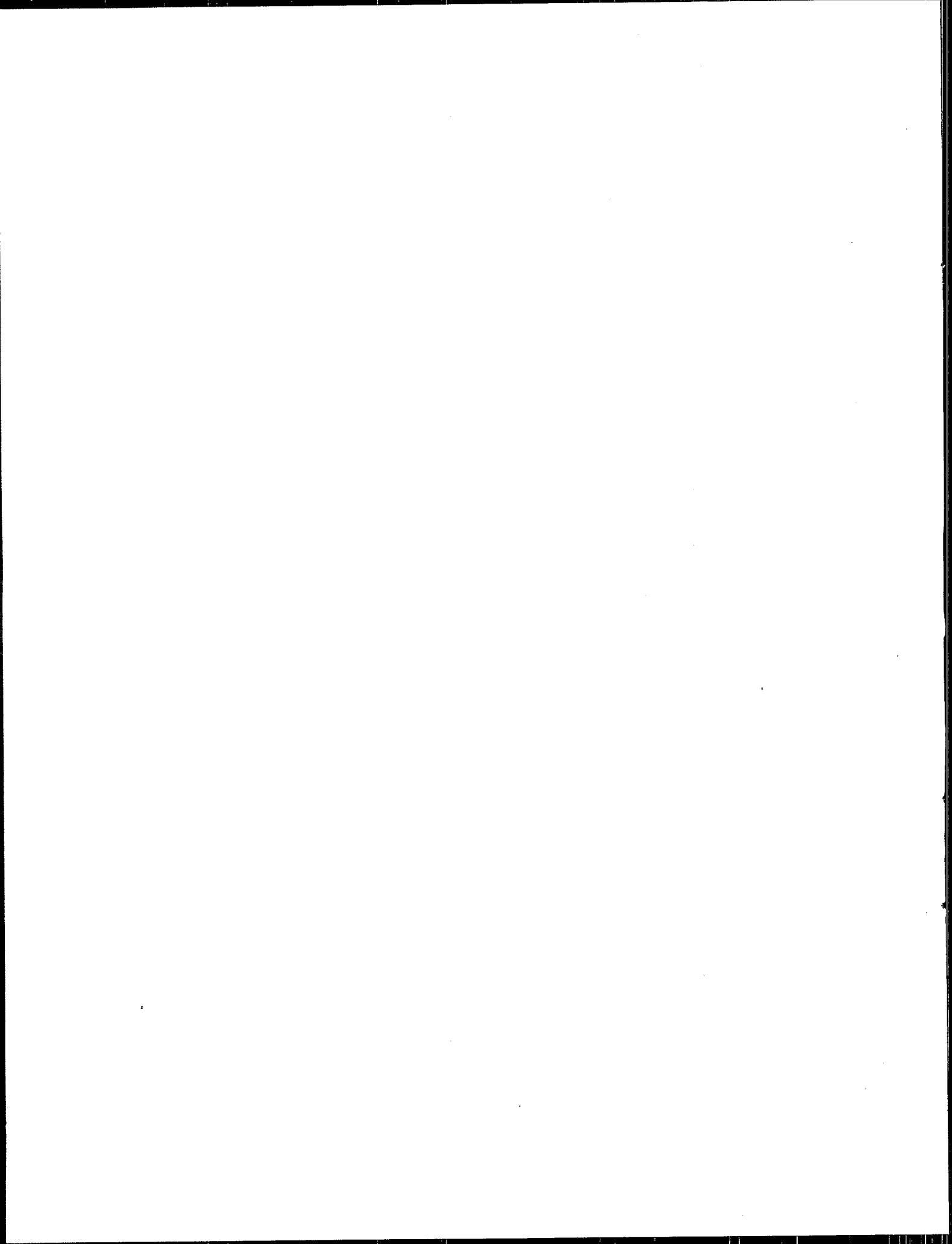

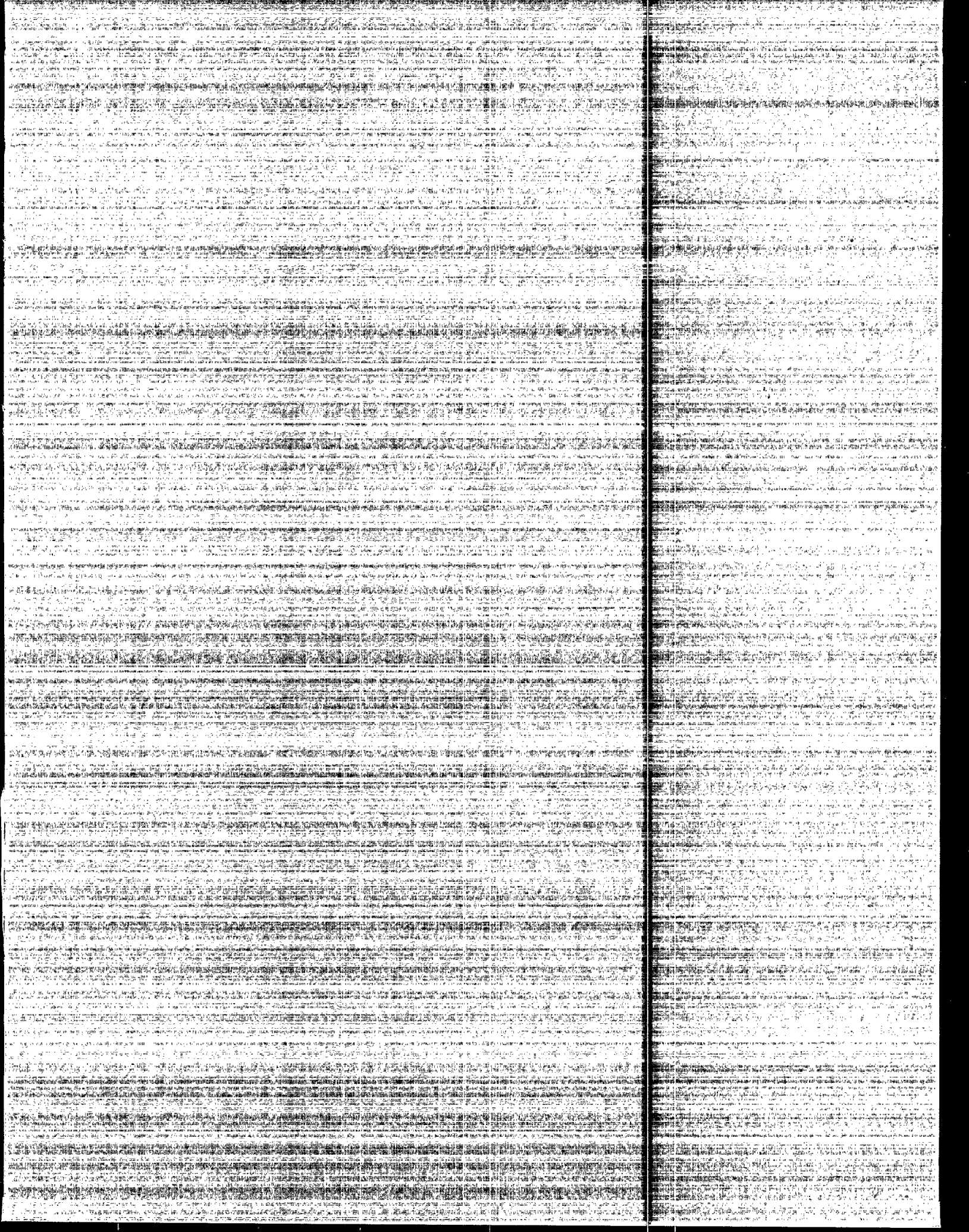
