

Saving Vital Resources: Water, Energy and Your Money



What is WAVE?

Wave) is a voluntary Efficiency (WAVE) is a voluntary partnership that encourages commercial businesses and institutions to examine water usage and implement water efficiency programs. It is part of the U.S. Environmental Protection Agency's (EPA's) long-term effort to prevent pollution and reduce demands on the nation's water and energy resources.

WAVE members use water-efficient technologies and implement water awareness initiatives, where profitable, to reduce their water use. Some WAVE Partners have achieved water use reductions of up to 30 percent through various efficiency measures. Increasing your water use efficiency also can help you save on energy, wastewater treatment, and maintenance costs.

Currently, more than 100 businesses and organizations participate in WAVE. Among those endorsing WAVE as economically and environmentally beneficial are the *American Water Works Association*, *American Hotel & Motel Association*, *Business for Social Responsibility*, and *Green Seal*.

La Quinta Inns, a charter WAVE Partner since 1995, has thus far reduced water use companywide by 20 percent through its aggressive water conservation program. La Quinta's 303 inns in 28 states have saved over 1 billion gallons of water.

Who Can Join WAVE?

All businesses, office buildings, schools, colleges and universities, institutions, governments, and other public or private organizations are eligible to join WAVE. Your organization can play one of two roles as a WAVE member—Partner or Supporter. Partners include hotels, schools, colleges and universities, businesses, and other commercial and institutional water users. Supporters are resource-conscious commercial and governmental entities such as water-service companies, equipment suppliers and manufacturers, water or wastewater utilities, energy utilities, state governments, municipalities, and consulting and engineering firms interested in promoting water efficiency.

What do WAVE Members Do?

WAVE members agree to survey their waterusing equipment and install water-efficient
upgrades, where profitable, within five years of
joining WAVE. In most cases, members find
increasing water efficiency is simple to do and
pays off quickly. Members also agree to consider
using water-efficient equipment in the design of
all new facilities. EPA asks members to report
annually on their water efficiency measures and
program successes

By joining WAVE you can increase your water efficiency and...

- Protect the Environment. Water efficiency helps to protect the environment by conserving water resources and natural habitats.
- **Conserve Energy.** Water efficiency lessens the amount of energy required for heating, pumping, and wastewater treatment.
- **Save Money.** Significant amounts of money car be saved through more efficient water use. Being water efficient can also reduce water-associated energy, maintenance, and chemical costs.
- Attract Customers. Environmental responsibility is a growing concern for more consumers every day, and WAVE membership can help you attract the "eco-sensitive" customer who actively seeks out businesses demonstrating strong environmental stewardship.
- Receive Industry-Wide and National Publicity. WAVE recognizes its members through press releases, articles, and public service announcements in EPA publications, trade journals, and other national publications.
