INTRODUCTION

This document provides a listing of commercial facilities that accept hazardous waste for treatment and/or recycling. The compilation of this directory arises out of a need to provide the public with a listing of information on the availability of treatment and recycling facilities in the United States; in addition to the types of wastes that each facility handles. This need is a direct result of the land disposal restrictions that stem from the Hazardous and Solid Waste Amendments (HSWA) of 1984.

With the advent of wastes being prohibited from land disposal, many generators of hazardous waste will need to consider alternative forms of waste management. This directory includes facilities permitted under RCRA (interim status or final status) that offer commercial treatment or recycling services, or are expected to offer these services after the permit process is completed. Each entry in the directory has been designated as either: 1) a commercial treatment facility; 2) a commercial recycling facility; or 3) a commercial treatment and recycling facility. These designations were developed after an analysis of currently available data bases which include: 1) EPA Hazardous Waste Data Management System; 2) Biennial Data for 1983; 3) Regulatory Impact Analysis Mail Survey of 1981; 4) listings of commercial facilities prepared by twelve states, the Hazardous Waste Treatment Council and the National Association of Solvent Recyclers.

EPA recognizes that since information in the above data bases dates from 1981-85, and the status of facilities is constantly changing, that the directory may include some incorrect entries and/or designations. To provide more comprehensive and updated information, EPA is currently developing a national study to characterize treatment and recycling services which will be completed in 1987. However, recognizing that many facilities will soon need to consider alternative treatment and recycling services, EPA decided that a listing of information currently available from EPA data bases would serve as a useful tool in identifying potential alternative treatment and recycling services. Therefore, EPA has decided to prepare the first edition of the directory from the best available information and then proceed to update the directory annually. Facilities using this directory will, of course, need to contact the

commercial facilities to obtain current information on the specific treatment and recycling services being offered.

For each commercial facility, the directory also provides the facility name, address, telephone number, contact, categories of treatment (i.e. tanks, surface impoundments, incineration, and other), and when available, types of hazardous waste managed at the facility. This information was obtained from the EPA Hazardous Waste Data Management System and the Regulatory Impact Analysis Mail Survey.

The information on types of hazardous waste managed at each facility was originally reported in the data bases as EPA hazardous waste listings. Although the waste listings have meaning within the regulatory framework of RCRA, they were not included in this directory. Waste groups or types of waste, such as "oil wastes" or "nonhalogenated solvents" were used because they convey more information regarding their "treatability" than hazardous waste listings such as K048 or F003. Therefore, a methodology was devised to convert hazardous waste listings into waste groupings.

The purpose of converting "listings" into "types" was to reduce approximately 500 RCRA waste listings into a manageable number of waste treatment groups. The waste listings were then placed into groups (types) based on their chemical similarities. For example, a facility handling F001 (various spent halogenated solvents from degreasing operations), U037 (chlorobenzene), U226 (1,1,1-trichloroethane), and U228 (trichloroethylene) would be identified in the directory as a facility handling halogenated solvents.

The primary criteria used in placing hazardous wastes into waste groups were: 1) original use of the chemical (e.g. solvents); 2) elemental chemical composition of the waste (e.g. metals); 3) characteristics of the waste (e.g. ignitable); and 4) the industries or processes that generate the waste (e.g. pharmaceuticals). These criteria were often combined to form the groups. For example, the halogenated solvents group was based on both the "usage" and the "elemental chemical structure" criteria. Table 1 presents a list of the waste groups and RCRA waste codes within each group. Table 2 presents a list of RCRA waste codes and the waste group or groups to which it has been classified.

For ease in locating facilities that handle specific types of waste, the first section of this directory consists of a table of the facilities, the types of processes (i.e. treatment, recycling, or both), and when available, the wastes managed. (If no waste types are indicated on the table, i.e. all the boxes are blank, the facility does provide commercial treatment and/or recycling services, but information on the specific waste types was not included in the data bases.) This section is listed alphabetically by state. The second section provides an alphabetical listing of facilities with the name of the facility, address, telephone number, contact person, type of processes, type of treatment, and waste group(s) when available.

This list does not constitute a list of approved recycling, treatment, storage, or disposal facilities. It is a compilation of data that is currently available from EPA data bases. It should be noted that a surface impoundment will not qualify as acceptable alternative treatment unless it meets the standards set forth in Section 3005(j)(11)(A) and (B) of RCRA (Vol. 51 Federal Register 1608-9, January 14, 1986).
