1551. In Re: Chemical Compounding Corp., EPA Region II, October 17, 1974. (I.F.&R. No. II-10C, I.D. No. 91906.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C.136j(a)(1)(E). The action pertained to a product held for distribution or sale on September 20, 1973, at Chemical Compounding Corp., Jersey City, New Jersey. The pesticide involved was CENTRAL VETSCO RIDZALL; charges included adulteration and misbranding—product's strength or purity fell below the professed standard of quality as expressed on its labeling.

The respondent was assessed a civil penalty of \$900.00 by the Final Order.

1552. In Re: Burris Chemical, Inc., EPA Region IV, November 12, 1974. (I.F.&R. No. IV-81C, I.D. No. 95351.)

This was a civil action charging the respondent with violating the federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(G); 136(q)(1)(F); 136(q)(2)(A); 135(a); 135a(a)(1); and 135b. The action pertained to a shipment made on July 10, 1973, from Atlanta, Georgia, to Cullman, Alabama. The pesticide involved was **FORMALDEHYDE 37%**; charges included nonregistration and misbranding—lack of adequate warning or caution statement, lack of adequate directions for use and lack of adequate ingredient statement on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,800.00.

1553. In Re: Stevens Industries, Inc., EPA Region IV, November 19, 1974. (I.F.&R. No. IV-93C, I.D. Nos. 88446, 116760 and 116764.)

EPA 730-

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(A); 136(c)(2); 136(q)(2)(C)(v); 136(c)(1); and 136(q)(1)(F). The action pertained to a shipment made on March 19, 1973, from Dawson, Georgia, to Dothan, Alabama, and to products held for distribution or sale on March 7, 1974, at Stevens Industries, Inc., Dawson, Georgia. The pesticides involved were MASTER BRAND 30% NEMAGON SOIL FUMIGANT GRANULES, MASTER BRAND VEGATABLE DUST MALATHION & DITHANE M-45 and MASTER BRAND PHOSDRIN SPRAY; charges included adulteration and misbranding—strength or purity of products below standard of quality represented on labeling, products were contaminated with additional active ingredients not declared on labeling, lack of adequate ingredient statement, lack of adequate directions for use, and lack of assigned registration number on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$3,800.00.

1554. In Re: Nottingham Company, EPA Region IV, December 23, 1974. (I.F.&R. No. IV-80C, I.D. No. 95352.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(G); 136(q)(1)(F); 136(q)(2)(A); and 135(o). The action pertained to a shipment made on November 26, 1973, from Atlanta, Georgia, to Cullman, Alabama. The pesticide involved was **CRESYLIC ACID**; charges included nonregistration and misbranding—labels did not bear an ingredient statement, directions for use and the required precautionary statements.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,200.00.

1555. In Re: Borden Chemical Company, EPA Region IV, January 6, 1975. (I.F.&R. No. IV-94C, I.D. No. 116286.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(G); 136(q)(1)(F); 136(q)(2)(A); 135(o); 136(q)(2)(C)(iii); and 136(q)(2)(C)(v). The action pertained to a shipment made on February 1, 1974, from Marietta, Georgia, to Lake Wales, Florida. The pesticide involved was VITA-BRITE VEGATABLE WAX JC 3550; the charge was misbranding—labels did not bear adequate precautionary statement, adequate directions for use, adequate ingredient statement, net content statement, and the assigned registration number.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,940.00.

1556. In Re: Erny Supply Company, EPA Region IV, January 6, 1975. (I.F.&R. No. IV-104C, I.D. No. 116257.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(A); and 136(c)(1). The action pertained to a product held for distribution or sale on March 28, 1974, at Erny Supply Company, Tampa, Florida. The pesticide involved was ESCO GERMICIDAL CLEANSER; charges included adulteration and misbranding—its strength or purity fell below the professed standard of quality as expressed on its labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,850.00.

1557. In Re: Riverside Chemical Company, EPA Region IV, January 9, 1975. (I.F.&R. No. IV-78C, I.D. No. 95344.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(c)(2). The action pertained to a product held for distribution or sale on January 29, 1974, at Riverside Chemical

Company, Montgomery, Alabama. The pesticide involved was **RIVERSIDE CHLORDANE 8**; the charge was adulteration—contaminated with methyl parathion.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$3,500.00.

1558. In Re: Thompson-Hayward Chemical Company, EPA Region IV, January 9, 1975. (I.F.&R. No. IV-95C, I.D. No. 116513.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(2)(D); and 136(q)(1)(G). The action pertained to a product held for distribution or sale on March 14, 1974, at Thompson-Hayward Chemical Company, Memphis, Tennessee. The pesticide involved was **DESICCANT-A**; the charge was misbranding—lack of adequate warning or caution statement and lack of the symbols or statements required for highly toxic substances on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$3,000.00.

1559. In Re: Velsicol Chemical Corporation, EPA Region IV, January 10, 1975. (I.F.&R. No. IV-98C, I.D. No. 112804.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1) and 135b. The action pertained to a shipment made on November 30, 1973, from Chattanooga, Tennessee, to Kansas City, Kansas. The pesticide involved was **BANVEL CAST ASSAY 77%**; the charge was nonregistration.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$2,240.00.

1560. In Re: Union Carbide Corporation, EPA Region IV, January 22, 1975. (I.F.&R. No. IV-88C, I.D. Nos. 116790, 116774, and 116283.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(F); 136(q)(1)(A); 135a(a)(1); and 135b. The action pertained to shipments made on February 22, March 12 and May 6, 1974, from Woodbine, Georgia, Jacksonville, Florida, and Sylvester, Georgia, to Jacksonville, Florida, Sylvester Georgia, and Fort Valley, Georgia. The pesticide involved was **TEMIK 15G ALDICARB PESTICIDE**; charges included nonregistration and misbranding—labels bore a false registration number implying that the product was registered and lack of adequate directions for use on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$8,000.00.

1561. In Re: Mayo Chemical Company, EPA Region IV, January 27, 1975. (I.F.&R. No. IV-97C, I.D. No. 116812.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(c)(1). The action pertained to a product held for distribution or sale on April 5, 1974, at Mayo Chemical Company, Smyrna, Georgia. The pesticide involved was MAYO ALGAECIDE; the charge was adulteration—its strength or purity fell below the professed standard of quality as expressed on its labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,480.00.

1562. In Re: C. D. Terhune Company, EPA Region IV, January 29, 1975. (I.F.&R. No. IV-102C, I.D. No. 116439.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodneticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(c)(1). The action pertained to a product held for distribution or sale on July 22, 1974, at C. D. Terhune Company, Cedartown, Georgia. The pesticide involved was **DIXIE MALATHION DUST**; the charge was adulteration—its strength or purity fell below the professed standard of quality as expressed on its labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$150.00.

1563. In Re: Helena Chemical Company, EPA Region IV, January 29, 1975. (I.F.&R. No. IV-92C, I.D. Nos. 116593 and 116900.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(G); 136(q)(2)(A); and 135(o). The action pertained to shipments made on March 15, 1973, and May 5, 1974, from Dothan, Alabama, and Tampa, Florida, to Marianna, Florida, and Laurinburg, North Carolina. The pesticides involved were HELENA BRAND LIQUID SULFUR EIGHT and FY-FANON MALATHION PREMIUM GRADE; charges included nonregistration and misbranding—lack of adequate warning or caution statement, lack of adequate directions for use, and lack of adequate ingredient statement on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$4,650.00.

1564. In Re: Wine Art of Minnesota, EPA Region V, August 1, 1974. (I.F.&R. No. V-083C, I.D. Nos 115201 and 115203.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(G); and 136(q)(2)(A). The

action pertained to a shipment made on February 13, 1974, from Minneapolis, Minnesota, to Tomah, Wisconsin. The pesticides involved were WINE ART SULPHITE CRYSTALS and WINE ART CHLORINE STERILIZER; charges included nonregistration and misbranding—lack of adequate warning or caution statement and lack of adequate ingredient statement on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$600.00.

1565. In Re: Brulin & Company, Inc., EPA Region V, August 13, 1974. (I.F.&R. No. V-050C, I.D. Nos. 102604, 87371, 87372, and 87374.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136(c)(1); 136(q)(1)(A); 136(q)(1)(F); 136(q)(1)(G); and 136j(a)(1)(E). The action pertained to a shipment made on December 8, 1972, from Indianapolis, Indiana, to Omaha, Nebraska, and to products held for distribution or sale on July 25, 1973, at Brulin & Company, Inc., Indianapolis, Indiana. The pesticides involved were BRULINCIDE 50, BRULIN KING SIZE BUG BOMB, BRULIN NO-TOX BRAND AEROSOL INSECTICIDE, and BOWLAIDE; charges included nonregistration, claims and directions differed from those represented in connection with the products registration, misbranding and adulteration—strength or purity fell below the standard of quality represented in labeling, lack of adequate warning or caution statements and labels bore false or misleading safety statements.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$3000.00.

1566. In Re: Castle Chemical Company, EPA Region V, August 16, 1974. (I.F.&R. No. V-053C, I.D. No. 93984.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 136j(a)(1)(E); 136(q)(1)(G); and 136(q)(2)(C)(iii). The action pertained to a product held for distribution or sale on August 24, 1974, at Castle Chemical Company, Savage, Minnesota. The pesticide involved was MALATHION 5-EC; charges included claims and directions differed from those represented in connection with the products registration and misbranding—lack of adequate warning or caution statements and lack of a net content statement.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1500.00.

1567. In Re: Federal International Chemicals, EPA Region V, August 16, 1974. (I.F.&R. No. V-040C, I.D. Nos. 92635 and 102491.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 136j(a)(1)(E); and 136(q)(1)(A). The action pertained to shipments made on February 23 and March 21, 1973, from Chicago, Illinois, to Sioux City, Iowa, and Grand Forks, North Dakota. The pesticides involved were FLOOR CARE SYSTEMS PHENE-A-CIDE 128 and LISTO-PHENE 256 CLEANER-DISFECTANT-DEODORANT; charges included claims and directions differed from those made in connection with registration and misbranding—labels bore a false registration number.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1000.00.

1568. In Re: Lowman Company, EPA Region V, August 16, 1974. (I.F.&R. No. V-064C, I.D. No. 93846.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1). The action pertained to a shipment made on November

30, 1972, from Waterloo, Indiana, to Concord, Michigan. The pesticide involved was **ACORN RAT & MOUSE KILLER**; the charge was composition differed from that represented in connection with its registration.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$750.00.

1569. In Re: Misco International Chemicals, Inc., EPA Region V, August 16, 1974. (I.F.&R. No. V-062C, I.D. No. 93720.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(c)(1); 136(q)(1)(A); 136(q)(1)(C);136(a)(1)(G); and 136(a)(2)(C)(iii). The action pertained to a shipment made on April 18, 1973, from Wheeling, Illinois, to Minneapolis, Minnesota. The pesticide involved was POOL CONDITIONER **SWIMMING** POOL CONCENTRATE ALGAECIDE SURFACE CONDITIONER; charges included nonregistration, misbranding and adulteration—label of the product bore a false registration number, product was an imitation of another pesticide. strength or purity of product fell below that represented on its labeling, lack of adequate warning or caution statements, misleading or false safety statements and failure to bear a net content statement.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1000.00.

1570. In Re: American Home Chemical Co., Inc., EPA Region V, August 19, 1974. (I.F.&R. No. V-031C, I.D. No. 92665.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(A); 136(q)(1)(G); and 136(q)(2)(A). The action pertained to a shipment made on February 19, 1973, from Indianapolis, Indiana, to Helena, Montana. The

pesticide involved was **RE ROOT ELIMINATOR**; charges included nonregistration and misbranding—lack of adequate warning or caution statements, lack of an ingredient statement and labels bore a false or misleading safety statement.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1571. In Re: Mortemoth Chemical Laboratories, Inc., EPA Region V, August 19, 1974. (I.F.&R. No. V-049C, I.D. No. 102208.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(G); and 136(q)(2)(D). The action pertained to a shipment made on or about May 14, 1973, from Milwaukee, Wisconsin, to Kansas City, Missouri. The pesticide involved was LETHOL FUR STORAGE FUMIGANT; charges included nonregistration and misbranding—lack of adequate warning or caution statement on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1572. In Re: BASF Wyandotte Corporation, EPA Region V, August 27, 1974. (I.F.&R. No. V-090C, I.D. No. 106248.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E). The action pertained to a product held for distribution or sale on December 11, 1973, at BASF Wyandotte Corporation, Wyandotte, Michigan. The pesticide involved was **SPARTEC QUATERNARY AMMONIUM COMPOUND**; the charge was misbranding—labeling bore a statement as to the safety of the product which was false or misleading.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1573. In Re: Carajon Chemical Co., Inc., EPA Region V, August 27, 1974. (I.F.&R. No. V-084C, I.D. No. 106229.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(q)(1)(G). The action pertained to a product held for distribution or sale on November 27, 1973, at Carajon Chemical Co., Fremont, Michigan. The pesticide involved was **FORCE'S POISON PEANUTS**; the charge was misbranding—label did not bear necessary warning and caution statements for the protection of health and the environment.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1000.00.

1574. In Re: Farmers Union Central Exchange, Inc., EPA Region V, August 27, 1974. (I.F.&R. No. V-068C, I.D. No. 93968.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(q)(2)(C)(v). The action pertained to a product held for distribution or sale on August 14, 1973, at Farmer's Union Central Exchange, St. Paul, Minnesota. The pesticide involved was CO-OP KETOSIS TREATMENT; the charge was misbranding—lack of assigned registration number on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1575. In Re: H. V. Smith Company, EPA Region V, August 27, 1974. (I.F.&R. No. V-067C, I.D. No. 93985.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(A) and 136(q)(1)(G). The action pertained to a product held for distribution or sale on August 24, 1973, at H. V. Smith Company, St. Paul, Minnesota. The pesticide involved was STERALEN CONCENTRATED CLEANER DISINFECTANT DEODORANT; the charge was misbranding—lack of adequate warning or caution statement on labels and the labels bore a false or misleading registration number implying that the product was registered under that number.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1576. In Re: Rose Exterminator Company, EPA Region V, September 12, 1974. (I.F.&R. No. V-088C, I.D. Nos. 106392 and 106393.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(A); and 136(c)(1). The action pertained to products held for distribution or sale on November 21, 1973, at Rose Exterminator Company, Cincinnati, Ohio. The pesticides involved were ROSEX KILLS RATS AND MICE and MAGIC BRAND RESIDUAL SPRAY; charges included misbranding and adulteration—strength or purity fell below the standard of quality represented in labeling and when used as directed the product would not be effective.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$2000.00.

1577. In Re: Terminix International, Inc., EPA Region V, September 12, 1974. (I.F.&R. No. V-070C, I.D. No. 94645.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C.

136j(a)(1)(E); 136(q)(1)(F); and 136(q)(1)(G). The action pertained to a product held for distribution or sale on October 15, 1973, at Terminix International, Inc., Cincinnati, Ohio. The pesticide involved was TERMINIX CHLORDANE WATER EMULSIFIABLE CONCENTRATE; the charge was misbranding—lack of adequate warning or caution statements to protect health and the environment.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1000.00.

1578. In Re: Watkins Products, Inc., EPA Region V, September` 16, 1974. (I.F.&R. No. V-081C, I.D. No. 94415.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(q)(1)(G). The action pertained to a product held for distribution or sale on September 27, 1973, at Watkins Products, Inc., Winona, Minnesota. The pesticide involved was **WATKINS PINE OIL DISINFECTANT**; the charge was misbranding—lack of adequate warning or caution statement on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1400.00.

1579. In Re: Middle States Oil Company, EPA Region V, September 19, 1974. (I.F.&R. No. V-043C, I.D. No. 104624.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136(q)(1)(A); 136(q)(2)(A); 136(q)(2)(C); 136(q)(1)(G); and 136j(a)(1)(E). The action pertained to a shipment made on May 21, 1973, from Lakewood, Ohio, to New Iberia, Iowa. The pesticide involved was NO PIDGE NO. 72 FOR BIRD AND INSECT CONTROL; charges included nonregistration and misbranding—lack of adequate warning or caution statement, lack of

adequate ingredient statement, lack of net content statement and labels bore false or misleading safety claims.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1580. In Re: Oil Kraft, Inc., EPA Region V, September 20, 1974. (I.F.&R. No. V-089C, I.D. No. 94648.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(c)(1). The action pertained to a product held for distribution or sale on October 16, 1973, at Oil Kraft, Inc., Cincinnati, Ohio. The pesticide involved was **KRAFT KEMUL-SAN**; charges included misbranding and adulteration—strength or purity fell below the standard of quality represented in labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1581. In Re: Standard T. Chemical Co., EPA Region V, September 23, 1974. (I.F.&R. No. V-004C, I.D. No. 87157.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(A); and 136(q)(1)(G). The action pertained to a shipment made on May 23, 1973, from Chicago, Illinois, to Ashland, Wisconsin. The pesticide involved was MONTGOMERY WARD LATEX INTERIOR FLAT ENAMEL LIFE 75–3300 WHITE; charges included nonregistration and misbranding—lack of adequate ingredient statement and labels bore false or misleading safety statement.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1000.00.

1582. In Re: Kirsto Company, EPA Region V, October 24, 1974. (I.F.&R. No. V-074C, I.D. No. 106270.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(c)(1). The action pertained to a product held for distribution or sale on January 29, 1974, at Kirsto Company, Lansing, Michigan. The pesticide involved was E-Z-FLO MANEB 7 DUST; charges included misbranding and adulteration—strength or purity fell below the standard of quality represented in labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1583. In Re: Claire Manufacturing Company, EPA Region V, November 7, 1974. (I.F.&R. No. V-086C, I.D. No. 106539.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(c)(1); and 136(q)(1)(A). The action pertained to a product held for distribution or sale on December 4, 1973, at Claire Manufacturing Company, Chicago, Illinois. The pesticide involved was SPRAYWAY P-51 INSECT SPRAY; charges included misbranding and adulteration—strength or purity fell below the standard of quality represented in labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1500.00.

1584. In Re: Harrison Oil Corporation, EPA Region V, November 7, 1974. (I.F.&R. No. V-063C, I.D. No. 94587.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(c)(1). The action pertained to a product held for distribution or sale on October 4, 1973, at Harrison Oil Corporation, Milwaukee, Wisconsin. The pesticide involved was **FAFCO**

HARVEST KING VAPONA CATTLE SPRAY; charges included misbranding and adulteration—strength or purity fell below the standard of quality represented in labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1585. In Re: Hub States Corporation, EPA Region V, November 13, 1974. (I.F.&R. No. V-044C, I.D. Nos. 87447 and 88632.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1): 136(c)(1); 136(q)(1)(A); 136(a)(1)(F); 136(a)(1)(G): 136(q)(2)(C)(v); and 136j(a)(1)(E). The action pertained to a shipment made on December 4, 1972, from Indianapolis, Indiana, to Savannah, Georgia, and to a product held for distribution or sale on Septmeber 9, 1974, at Hub States Corporation, Indianapolis, Indiana. The pesticides involved were HUB STATES MOTH PROOF SPRAY and PYRETHRINS EMULSION CONCENTRATE: charges included claims and directions differed from those made in connection with registration, misbranding, and adulteration—strength or purity fell below the standard of quality expressed on its labeling. lack of adequate directions for use, lack of adequate warning or caution statements, failure to bear assigned registration number and labels bore false or misleading safety claims.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$3500.00.

1586. In Re: Madison Chemical Company, Inc., EPA Region V, November 15, 1974. (I.F.&R. No. V-092C, I.D. No. 115488.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(A);136(c)(1); and 136(q)(2)(C)(iii). The action pertained to a product held for distribution or sale on April 18, 1974, at Madison Chemical Co., Inc., Madison, Indiana. The pesticide

involved was MADISON QUATERNARY SANITIZING AGENT; charges included misbranding and adulteration—strength or purity fell below the standard of quality represented in labeling and label failed to bear a statement of net weight.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1587 In Re: Frank J. Curran Co., EPA Region V, December 6, 1974. (I.F.&R. No. V-048C, I.D. Nos. 94516, 94506 and 94513.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(a); and 136(q)(2)(C)(v). The action pertained to products held for distribution or sale on September 19, 1973, at Frank J. Curran Co., Downers Grove, Illinois. The pesticides involved were CURRAN MOTHCAKE, CURRAN PARA MOTH NUGGETS and CURRAN LAVENDER PARA BLOCK; charges included nonregistration, directions differed from those made in connection with registration and misbranding—labels failed to bear the registration number assigned and labels bore false registration numbers implying that the product was registered.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1588. In Re: J. T. Eaton & Co., Inc., EPA Region V, December 6, 1974. (I.F.&R. No. V-099C, I.D. No. 106362.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(q)(1)(A). The action pertained to a product held for distribution or sale on November 1, 1973, at J. T. Eaton & Co., Inc., Cleveland, Ohio. The pesticide involved was EATON'S ALL WEATHER BAIT BLOCKS RODENTICIDE; the charge was mis-

branding—when used as directed the product would not be effective and the product labeling bore false and misleading statements.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$700.00.

1589. In Re: Lawn House Products, Inc., EPA Region V, December 6, 1974. (I.F.&R. No. V-100C, I.D. No. 115082.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(A); and 136(c)(1). The action pertained to a product held for distribution or sale on February 26, 1974, at Lawn House Products, Inc., Milwaukee, Wisconsin. The pesticide involved was LIFE PRE-CRABGRASS KILLER WITH TURF FOOD; charges included misbranding and adulteration—strength or purity fell below the professed standard of quality as expressed on its labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1590. In Re: Val-A-Company, EPA Region V, December 13, 1974. (I.F.&R. No. V-036C, I.D. No. 93874.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 135b; 136j(a)(1)(E); 136(q)(1)(F); and 136(q)(1)(G). The action pertained to a shipment made on June 29, 1973, from Chicago, Illinois, to La Porte, Indiana. The pesticide involved was BONIDE BONCOP INSECTICIDE-FUNGICIDE; charges included nonregistration and misbranding—lack of adequate warning or caution statement and inadequate directions for use.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1000.00.

1591. A. I. Root Company of Iowa, EPA Region VII, November 19, 1974. (I.F.&R. No. VII-074, I.D. No. 114312.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136i(a)(2)(M). The action pertained to a false report made on May 20, 1974, from Council Bluffs, lowa, to the Environmental Protection Agency, Region VII, Kansas City, Missouri. The pesticide involved was **PARADICHLOROBENZENE** (PDB); the charge was to submit a pesticides report pursuant to Section 7 that had been knowingly falsified.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,650.00.

1592. In Re: Blue White Chemical Company, EPA Region VII, November 22, 1974. (I.F.&R. No. VII-56C, I.D. No. 112732.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1) and 135b. The action pertained to a shipment made on September 13, 1973, from St. Louis, Missouri, to Washington Park, Illinois. The pesticide involved was **BLUE WHITE CHEMICALS FOGGY – 1 8000–1**; the charge was nonregistration.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$420.00.

1593. In Re: Continental Research Corporation, EPA Region VII, November 26, 1974. (I.F.&R. No. VII-55C, I.D. Nos. 91616 and 115601.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136(q)(1)(A); 136(q)(1)(G); 136(q)(1)(D); 136j(a)(1)(E); 136(c)(1); 135a(a)(1); and 135b. The action pertained to shipments made on February 15 and March 20, 1974, from St. Louis, Missouri, to St.

Jacob and Hopedale, Illinois. The pesticides involved were DY-FLY FILTER FLY CONCENTRATE and CR-1:25 WEED, TREE, AND GRASS KILLER; charges included nonregistration, adulteration and misbranding—strength or purity fell below the professed standard of quality as expressed on its labeling, lack of warning or caution statement on labels, lack of establishment registration number on product, and labels bore a false or misleading statement.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$6,000.00.

1594. In Re: Kemin Industries, Inc., EPA Region VII, December 3, 1974. (I.F.&R. No. VII-61C, I.D. No. 112205.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(A); 136(c)(2); and 136(q)(1)(G). The action pertained to a product held for distribution or sale on June 13, 1974, at Kemin Industries, Inc., Des Moines, Iowa. The pesticide involved was **KEMIN GRAIN TREET (LIQUID)**; charges included adulteration and misbranding—lack of warning or caution statement on labels and another substance had been substituted wholly or in part for an active ingredient named on the label.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$6,500.00.

1595. In Re: Campbell Chemicals, Inc., EPA Region VII, December 27, 1974. (I.F.&R. No. VII-77C, I.D. Nos. 102656, 102659, 102661, and 112730.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(q)(1)(G); 136(q)(1)(F); 136(q)(1)(A); 136(q)(2)(c)(v); and 136a(a). The action pertained to a shipment made on April 5, 1973, from St. Louis, Missouri, to East St. Louis, Illinois, and to products held for distribution or sale on August 18 and 28, 1973, at

Campbell Chemicals, Inc., St. Louis, Missouri. The pesticides involved were NEW SUPER CAMICIDE INSECT BOMB, INDUSTRIAL FORMULA SUPER STRENGTH CAMICIDE PUSH BUTTON BUG KILLER, CAMIE BUG KILLER AND REPELLENT, and NEW SUPER # 100 CAMIE INSECT SPRAY; the charge was misbranding—lack of adequate warning or caution statement, lack of adequate directions for use, lack of assigned registration number and labels bore false safety claims.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,470.00.

1596. In Re: United Chemical Company, Inc., EPA Region VII, December 31, 1974. (I.F.&R. No. VII-79C, I.D. No. 102262.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E) and 136(q)(1)(G). The action pertained to a product held for distribution or sale on September 6, 1973, at United Chemical Company, Inc., Kansas City, Missouri. The pesticide involved was **D-DISINFECTANT**; the charge was misbranding—lack of adequate precautionary statements on labels.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$378.00.

√ 1597. In Re: Leffingwell Chemical Co., Division of Thompson-Hayward Chemical Co., Inc., EPA Region IX, November 6, 1974. (I.F.&R. No. IX-66C, I.D. Nos. 105976 and 105977.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1). The action pertained to products held for distribution or sale on January 24, 1974, at Leffingwell Chemical Co., Brea, California. The pesticides involved were HI-PAR and NUTRA-SPRAY BASIC COPPER CARBONATE; charges included claims

made for it and the directions for its use differed in substance from the representations made in connection with its registration.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$4,000.00.

1598. In Re: Morgan-Gallacher, Inc., EPA Region IX, November 14, 1974. (I.F.&R. No. IX-71C, I.D. No. 113709.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(E); 136(c)(1); and 136(q)(1)(A). The action pertained to a product held for distribution or sale on April 25, 1974, at Morgan-Gallacher, Inc., Cudahy, California. The pesticide involved was 'ACIDISOL' CONCENTRATED ACID SANITIZER; charges included adulteration and misbranding—strength or purity of product fell below the professed standard of quality as expressed on its labeling.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$1,000.00.

1599. In Re: Mission Kleensweep Products, Inc., EPA Region IX, December 2, 1974. (I.F.&R. No. IX-55C, I.D. No. 102066.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 135a(a)(1); 136j(a)(1)(E); and 136(q)(1)(E). The action pertained to a shipment made on November 7, 1973, from Los Angles, California, to Cedar City, Utah. The pesticide involved was **PINE-O-LAV**; charges included nonregistration and misbranding—precautionary statement was not prominently placed on the label as required.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$500.00.

1600. In Re: Alden-Leeds Company, EPA Region IX, January 10, 1975. (I.F.&R. No. IX-26C, I.D. No. 69249.)

This was a civil action charging the respondent with violating the Federal Insecticide, Fungicide, and Rodenticide Act, 7 U.S.C. 136j(a)(1)(B) and 136j(a)(1)(E). The action pertained to a shipment made on June 5, 1973, from Ontario, California, to Phoenix, Arizona. The pesticide involved was **NU-CLO 85 DESERT STABILIZED CHLORINE GRANULES**; charges included claims differed substantially from those made in connection with its registration and misbranding—precautionary statements were not prominently placed on the label as required.

The respondent signed a Consent Agreement. The Final Order assessed a civil penalty of \$300.00.
