

The list below displays the applicants for EPA's 2018 School Bus Rebate Program that were not selected in the lottery process. If any 2018 rebate selectees drop out of the program, EPA will try to offer their unused funds to previously unselected applicants based on the order of the list below. Dropouts are not common, so we do not recommend that fleets in this waiting list adjust their normal bus procurement schedule in the hope of being selected.
