

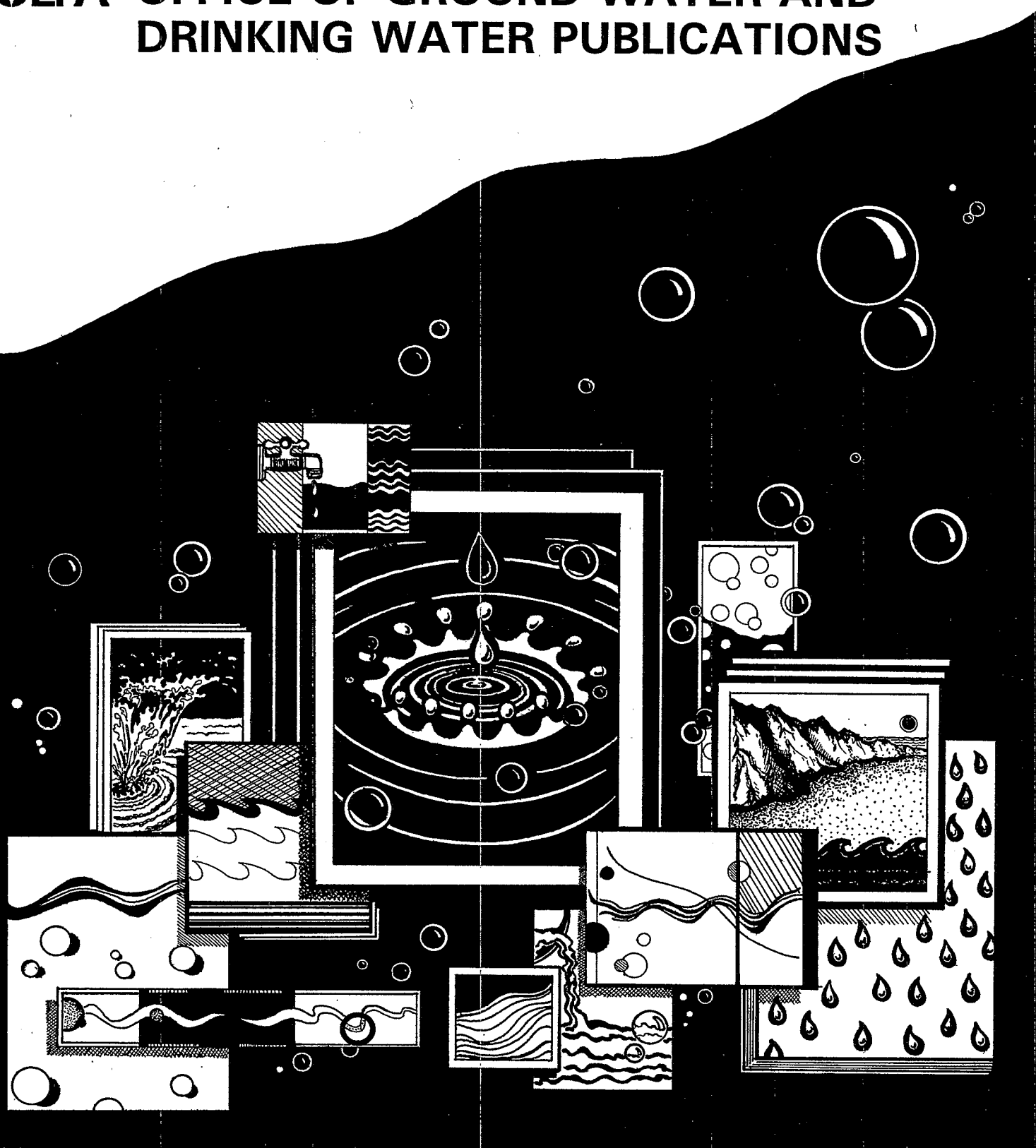

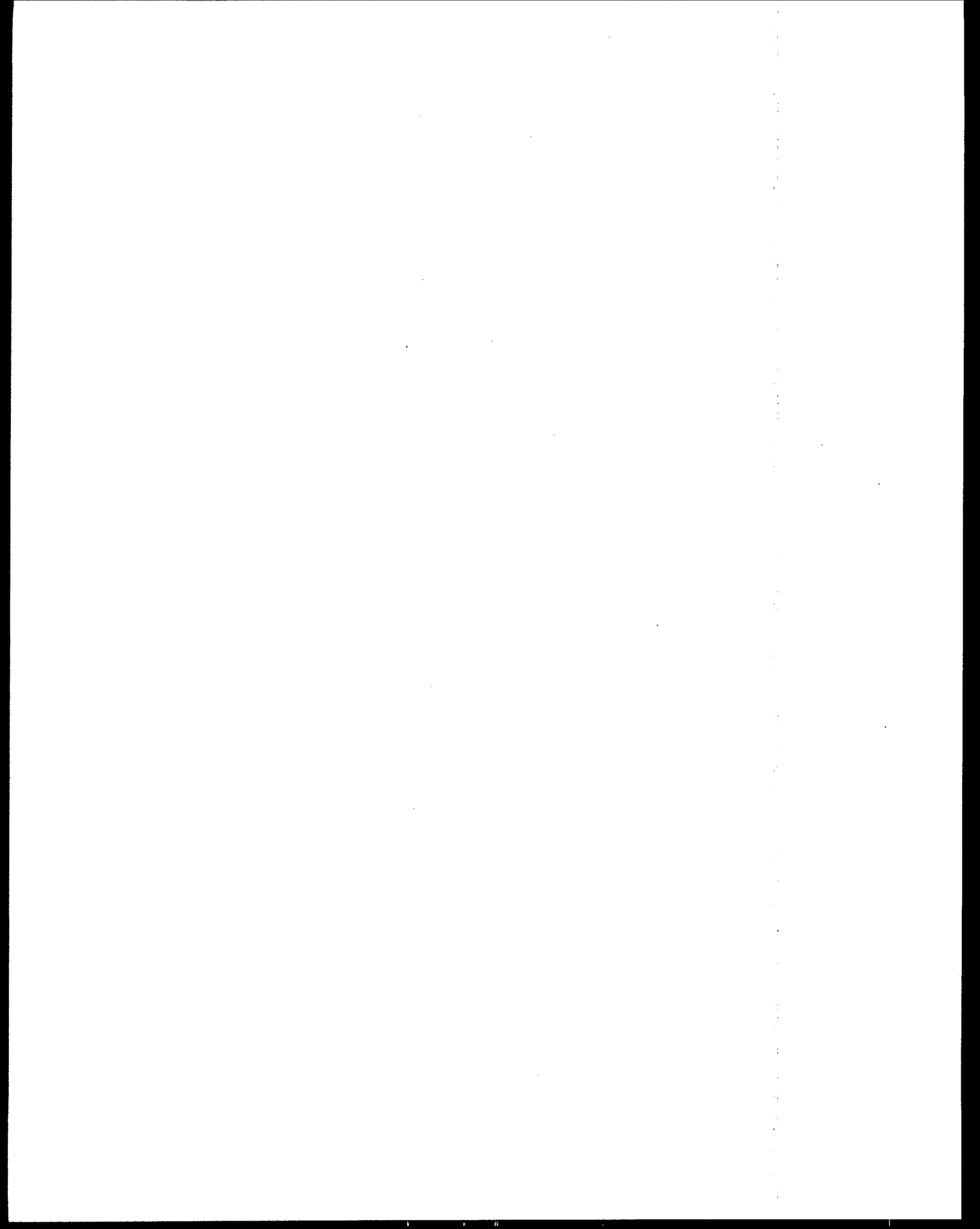

HOW TO USE THIS CATALOG

General Information

Many publications in this catalog are distributed free of charge by the EPA's Office of Ground Water and Drinking Water (OGWDW). The Office of Ground Water and Drinking Water distributes documents through the National Clearinghouse for Publications and Information (NCEPI) or the EPA Office of Water Resource Center (WRC). The NCEPI and the WRC distribute up to ten free copies of each publication to each customer until supplies are depleted.

When OGWDW's supply of a publication is depleted, requestors are referred to either the National Technical Information Service (NTIS) or the Educational Resources Information Center (ERIC). These clearinghouses provide copies of OGWDW publications for a fee.

Catalog Organization

This catalog divides the documents into nine sections: 1) Bibliographies; 2) Fact Sheets, Brochures and Pamphlets; 3) Technical Assistance Documents; 4) Youth Education; 5) Wellhead Protection; 6) Underground Injection; 7) Scientific/Fact Finding Reports; 8) National Pesticide Survey (NPS); and 9) Legislation and Federal Register notices.

The Office of Ground Water and Drinking Water has assigned most documents a unique EPA number to assist in tracking the document. Documents are listed in order by EPA number within each section. Documents without EPA numbers appear at the end of each section.

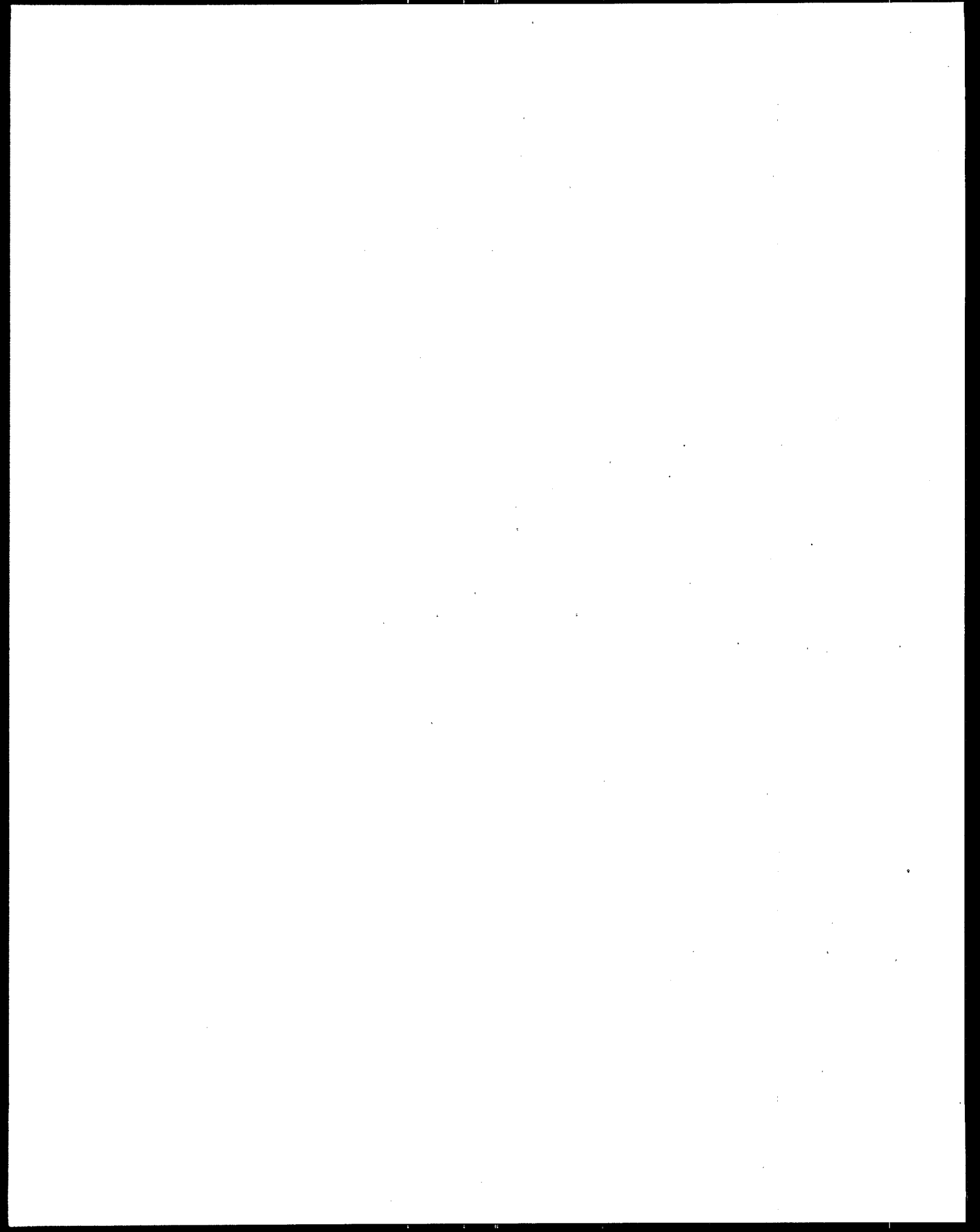

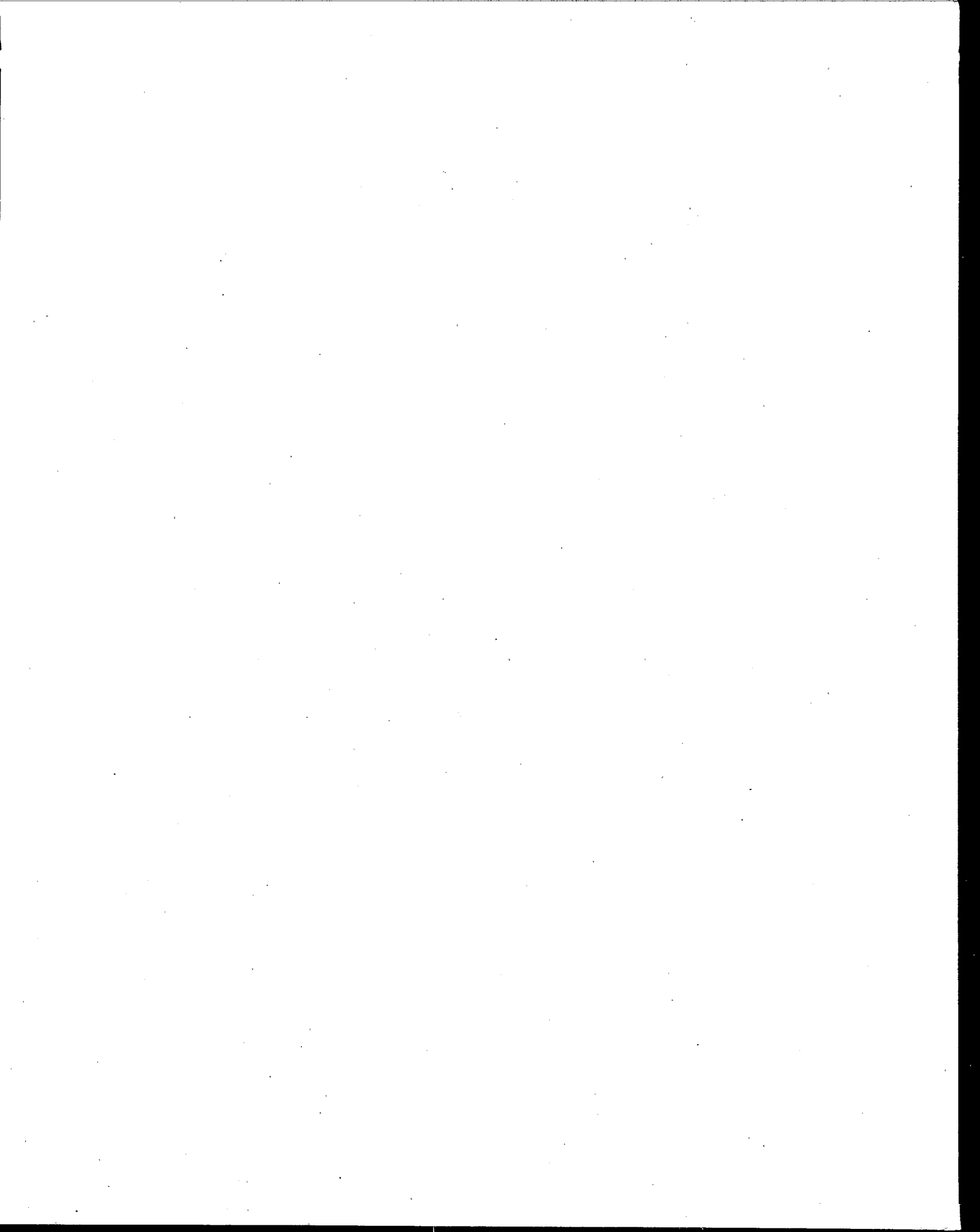

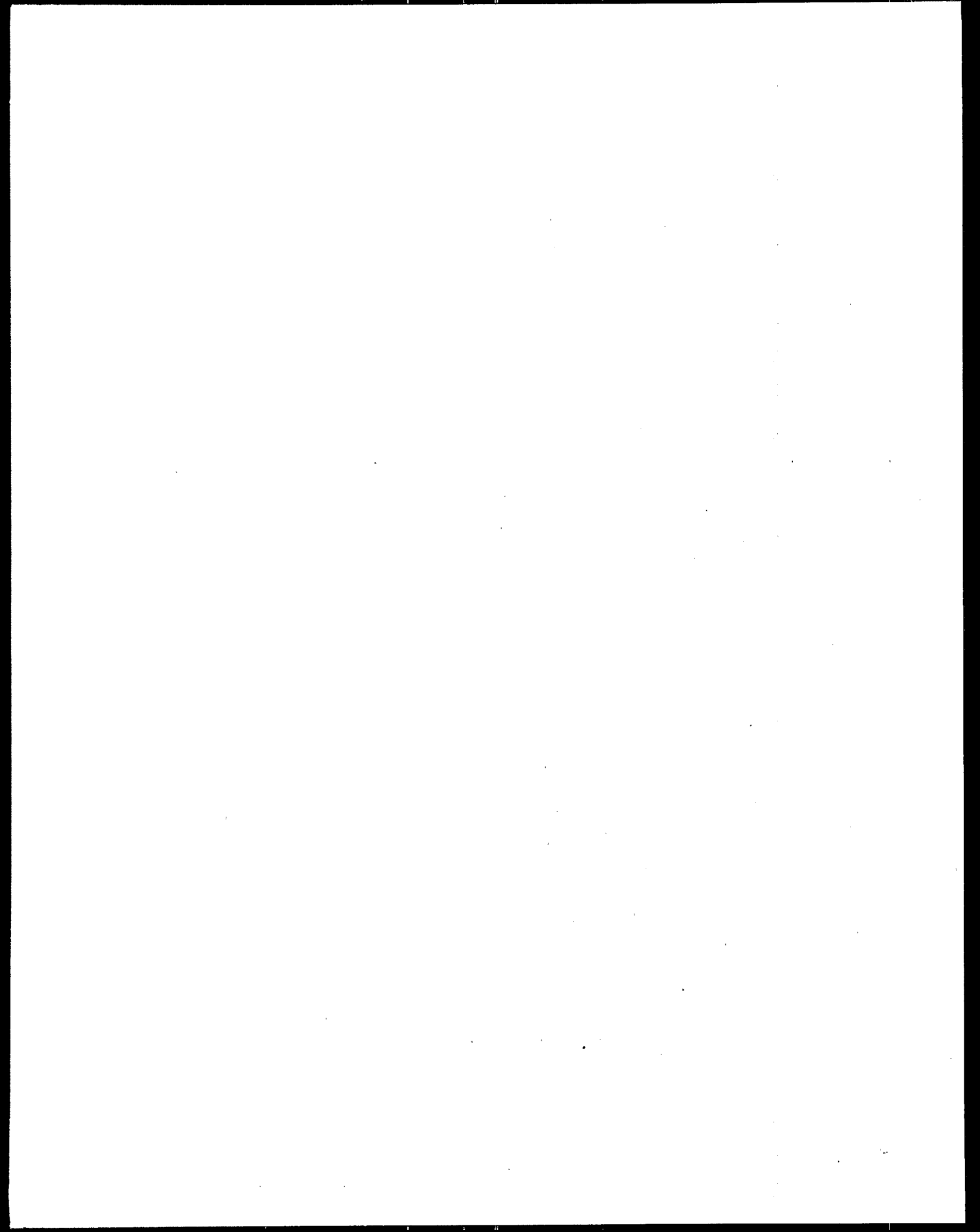

Background

The U.S. Environmental Protection Agency's (EPA's) Safe Drinking Water Hotline is available to help the regulated community, State and local officials, and the public understand the regulations and programs developed in response to the Safe Drinking Water Act Amendments of 1986.

Purpose

The Hotline can provide callers with information about EPA's drinking water regulations, guidance, and public education materials. Specifically, the Hotline staff can:

- Clarify drinking water regulations and provide appropriate Federal Register and Code of Federal Regulation citations, and explain EPA's policies and guidelines
- Provide updates on the status of drinking water regulations and policies
- Provide information on the availability of technical publications, guidance documents, and regulations regarding drinking water and ground water
- Provide information on the availability of public information materials such as brochures and pamphlets regarding drinking water and ground water
- Provide Federal, State, and local contacts for specific information on local drinking water conditions, bottled water, home water treatment units, and ground water protection. (The Hotline, however, cannot discuss manufacturers or recommend brandname water treatment units.)
- Provide State contacts for EPA-certified labs that test drinking water. The State Lab Certification Officer can then provide callers with certified labs in their area.

Operator

The Hotline is operated by LABAT-ANDERSON Incorporated under contract to EPA's Office of Ground Water and Drinking Water.

Staffing

The Information Specialists have expert knowledge of EPA's drinking water regulations and policies, gained through a comprehensive training program and daily interaction with the Office of Ground Water and Drinking Water.

Hours of Operation

The Safe Drinking Water Hotline operates Monday through Friday, 9:00 a.m. to 5:30 p.m., ET, excluding Federal holidays.
