



WASTEWATER TREATMENT PROGRAMS AVAILABLE TO NATIVE AMERICANS



A large number of homes in Indian country lack adequate systems to treat or dispose of sewage, according to a 1998 report by the Indian Health Service. If not properly collected, treated, or disposed of, wastewater can seriously affect the health of our citizens, our groundwater, and our surface waters. EPA's Office of Wastewater Management provides financial and technical assistance programs and resource centers to aid Native Americans with the construction and operation of wastewater facilities. Clean Water Indian Set-Aside (ISA) Grant Program

Program provides grants to Indian tribes and Alaskan Native Villages for the planning, design, and construction of wastewater treatment systems.
