The National Priorities List (NPL) identifies the targets for action under the Comprehensive Environmental Response, Compensation, and Liability Act of 1980 (CERCLA or "Superfund"). The law sets up a Trust Fund (expected to total \$1.6 billion) to help pay for cleaning up hazardous waste sites that threaten public health or the environment. The fund is administered by the U.S. Environmental Protection Agency (EPA).

To date, EPA has inventoried almost 16,000 uncontrolled hazardous waste sites. To be eligible for a remedial action under Superfund, however, a site must be included in the NPL. In October 1981, EPA published an interim priority list of 115 sites and followed with an expanded eligibility list of 45 additional sites in July 1982, for a total of 160 sites. EPA published a list of 418 sites as a proposed rule in December 1982, including 163 of the 160 sites previously published. Times Beach, Missouri, was proposed in March 1983, bringing the total proposed list to 419. After a period of public comment, EPA analyzed the comments and is now publishing the NPL, also referred to as the current NPL, as a final rule. At the same time, EPA is proposing new sites in its first NPL update, which CERCLA requires at least annually.

This publication includes three lists:

- ° The 406 sites that met the criteria for inclusion in the current NPL, as ranked by EPA.
- ° The 133 sites on the first proposed NPL update, as ranked by EPA.
- ° NPL and proposed updates sites arranged by State. NPL sites are listed first alphabetically, followed by update sites listed alphabetically.

CURRENT NATIONAL PRIORITIES LIST (NPL)

Each entry on the NPL of 406 sites contains the name of the site, the State and city or county in which it is located, and the corresponding EPA Region. The entries are arranged according to their scores on the Hazard Ranking System (HRS). HRS scores are designed to take into account a standard set of factors related to risks from migration of substances through ground water, surface water, and air. The list serves both as an information and management tool, allowing EPA to decide which sites warrant detailed investigation to determine what, if any, response is needed.

The 406 sites are in nine groups, 50 to a group (except for the last group). The scores on the NPL (except for some sites designated by States as their top priority) range from 75.6 to 28.5, the cut-off point selected for the December 1982 proposal to identify at least 400 sites, the minimum number specified by CERCLA. The range within most of the groups of 50 is only 3 to 5 points. EPA considers sites within these groups to have approximately the same priority.

CERCLA allows each State or territory to designate a top priority site; 36 did so. These sites must be listed in the first 100, regardless of score. Of the 36 top priority sites, 9 are included in the first 100 on the basis of their scores. The remaining 27 have scores that would not place them in the top 100. They are included at the bottom of the second group of 50. Of the 27, 7 have scores below 28.5. Top priority sites are designated by asterisks.

Of the 419 proposed sites, 14 are not included in the final rule, and one has been split into two sites, making a total of 406 sites on the current NPL published in August 1983. The 15 sites and their disposition:

- ° Five sites are not included because of score changes resulting from EPA's review of comments and other information. A total of 143 scores changed, but in only these five cases did the new score drop below the cut-off point of 28.5. These five sites will not be eligible for future remedial funding. They are:
 - Crittenden County Landfill, Marion, Arkansas
 - Flynn Lumber Co., Caldwell, Idaho
 - Parrot Road Dump, New Haven, Indiana
 - Phillips Chemical Co., Beatrice, Nebraska
 - Van Dale Junkyard, Marietta, Ohio
- ° One site, Gratiot County Golf Course, St. Louis, Michigan, has been cleaned up by the responsible party and so is not included in the final list.
- ° One site, Plastifax, Inc., Gulfport, Mississippi, is not included because it is no longer designated the State's top priority, and its score is below the cut-off point.

- ° On seven sites, rulemaking is pending because EPA is still reviewing the technical comments and resolving final scores. These seven sites will continue to be eligible for remedial funding. EPA will gather data needed to calculate final scores. The seven sites are:

Kingman Airport Industrial Area, Kingman, Arizona
Airco, Calvert City, Kentucky
Bayou Sorrel, Bayou Sorrel, Louisiana
Clare Water Supply, Clare, Michigan
Electrovoice, Buchanan, Michigan
Littlefield Township Dump, Oden, Michigan
Whitehall Well Field, Whitehall, Michigan

- ° One site, Vestal Water Supply, Vestal, New York, has been split into two sites--Vestal Water Supply Well 1-1 and Vestal Water Supply Well 4-2--because EPA discovered that there are two separate plumes of contaminated ground water from two separate sources. Both remain on the current NPL.

Status: Each entry is accompanied by one or more notations describing the current status of response and enforcement activities at the site. The notations are:

- V Conditions are currently being addressed through EPA-sanctioned voluntary actions by parties responsible for wastes at the site.
- R Conditions are currently being addressed through response actions funded by CERCLA.
- E Conditions are currently being addressed through a State or Federal enforcement action against parties responsible for wastes at the site.
- D EPA is considering various alternatives for this site. This includes all sites not listed in any other category.

Site Distribution: Of the 50 States, the District of Columbia, and six territories, 48 are represented. New Jersey has the largest number of sites with 65, followed by Michigan (41), Pennsylvania (30), New York (27), and Florida (25). Alaska, the District of Columbia, Georgia, Hawaii, Mississippi, Nebraska, Nevada, the Virgin Islands, and Wisconsin have no sites on the current NPL.

PROPOSED UPDATE TO NPL

The 133 sites on the first proposed NPL update are also listed in order of their HRS scores, which range from 63.1 to 28.5, with two exceptions: Flowood, in Flowood, Mississippi, the State's top priority site, and Quail Run Mobile Manor in Gray Summit, Missouri, which EPA believes involves special circumstances. In the winter of 1982-1983, EPA detected widespread dioxin contamination at Quail Run. The Centers for Disease Control subsequently issued a public health advisory warning that residents were exposed to a significant risk from direct contact with dioxin. Because the risk of direct contact is not presently used in calculating total HRS scores, Quail Run's score is below the cut-off point. By being on the proposed update, Quail Run is eligible for remedial action funded by CERCLA. Later, EPA intends to propose a limited numbers of alternative criteria for listing.

Each proposed update site is placed on the basis of its score in one of nine groups corresponding to the nine groups in the current NPL--for example, the eight sites in Group I of the update have scores comparable to the scores of the first 50 sites in the current NPL.

Status: Each entry is accompanied by one or more of the notations describing the current status.

Site Distribution: Of the 50 States, the District of Columbia, and six territories, 28 proposed sites. Wisconsin is included for the first time. Alaska, the District of Columbia, Hawaii, Nebraska, Nevada, and the Virgin Islands continue to have no sites on either the current NPL or proposed update. The sites are distributed as follows:

NPL AND PROPOSED UPDATE SITES, BY STATE

A total of 546 sites appear on the list arranged by State: 406 on the NPL, 7 on which rulemaking is pending, and 133 on the proposed update.


For each State, the NPL sites (including the seven pending) are listed first alphabetically, followed by the proposed update sites, also alphabetically. After the period of public comment and revisions, the pending and proposed sites that continue to score above the cut-off will be merged into the current NPL.

When all sites are combined, New Jersey has the largest number with 85, followed by Michigan (48), Pennsylvania (39), Florida (29), New York (29), Minnesota (23), Ohio (22), and Wisconsin (20).


Landfilling of hazardous substances was the major type of operation, taking place at 216 sites, or about 40 percent of the total. Other major activities were surface impoundments (30 percent), drums (22 percent), open dump (17 percent), above-ground tanks (11 percent), piles (9 percent), and transportation (9 percent). Also represented were: below-ground tanks, recycling/recovery, incineration, midnight dumping, chemical/physical treatment, waste oil processing, solvent recovery, landfarming, underground injection, and biological treatment.

Most of the sites had problems involving ground water. At 410 sites (75 percent), hazardous substances were detected in ground water. About 56 percent of the sites had problems with surface water, and 20 percent with air.


NATIONAL PRIORITIES LIST
