



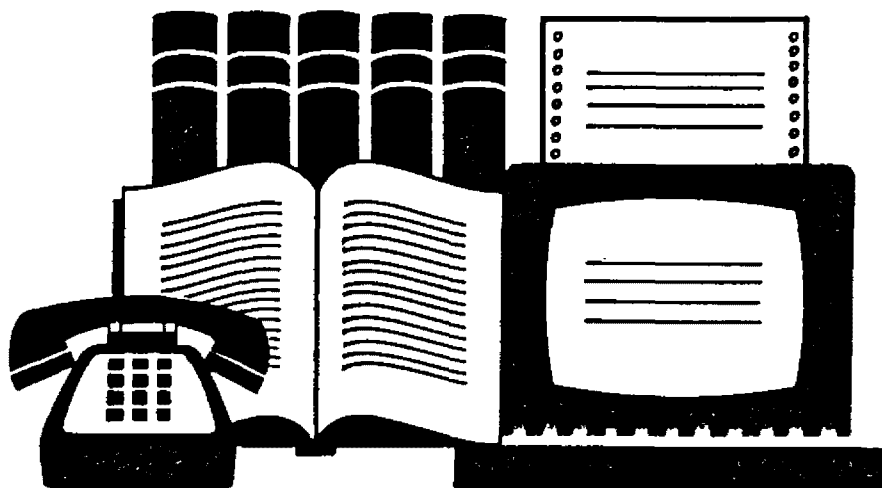

Abstracting and Indexing Services

Environment Abstracts. 1970--present. A monthly subject index to journal articles, conference papers and technical reports published in the environmental literature. Includes a short summary of each document cited. Published by EIC, Inc., which will provide copies of documents for an additional fee.

EPA Publications Bibliography. 1970 to present. Quarterly indexes to EPA technical reports by title, subject, personal author, contractor, report number, contract number, and sponsoring office. (Two cumulations covering the years 1970-76 and 1977-83 have been produced.) Abstracts of each report are included. Published by the National Technical Information Service. Copies of reports listed in the Bibliography can be purchased from NTIS.

Government Reports Announcements. 1970 to present. Semimonthly index to technical reports sponsored or produced by the federal government. Includes abstracts. Published by the National Technical Information Service. All reports are available for purchase from NTIS.

Monthly Catalog of US Government Publications. 1968 to present. Monthly index to publications of the federal government including the US Congress, the Environmental Protection Agency and the US Geological Survey. Published by the US Government Printing Office.

Pollution Abstracts. 1976 (vol. 6) to present. Subject/author index to technical journal articles, conference proceedings, books, papers and government documents in the environmental field. Abstracts included. Produced by Cambridge Scientific Abstracts. No document service.

Selected Water Resources Abstracts. 1969--1980. Monthly index to books, journal articles, reports and other publications. Covers water resources as treated in the life, physical and social sciences and related areas such as engineering and law. Published by the US Dept. of the Interior.

Data Bases

ENVIROLINE. Online index to 120,000+ journal and newspaper articles, government documents, reports, proceedings, films and books published from 1971 to the present. Updated monthly. Equivalent of Environment Abstracts. Copies of the full text of cited documents can be purchased from the producer, EIC, Inc., for an additional fee.

GPO Monthly Catalog. Includes 263,000+ records from 1976 to the present. Updated monthly. Contains information on publications of all US government agencies and the US Congress. Covers US Geological Survey material. Online equivalent of Monthly Catalog of US Government Publications.

Ground Water On-line. Contains citations to 50,000+ articles, conference papers, government documents (with special emphasis on publications of the US Environmental Protection Agency and the US Geological Survey). Can be searched by state and county as well as topic and author. Updated monthly. Produced by the National Ground Water Information Center and managed by the National Water Well Assn. Document service available.

NTIS (National Technical Information Service). One of the largest data bases containing over 1,215,000 records from 1964 to the present. Multidisciplinary data base containing citations and abstracts of federal government research reports. Includes EPA and Interior publications. Equivalent of the Government Reports Announcements. Produced by NTIS which will supply full text documents for an additional fee.

Pollution Abstracts. 124,000+ records covering 1970 to the present. Updated bimonthly. Includes citations and abstracts of environmental literature such as journal articles, books, conference papers, etc. Produced by Cambridge Scientific Abstracts. Online equivalent of the indexing service Pollution Abstracts.
