# The Toxic Release Inventory

#### Introduction

The law requires that the TRI be made available and accessible to the public by a telecommunications computer system and in other useful published formats. This guide is meant to put this information for acquiring TRI products right at your fingertips.

Section 313 of the Emergency Planning and Community Right-to-Know Act of the Superfund Amendments and Reauthorization Act of 1986 (Public Law 99-499) requires EPA to establish a National Inventory of toxic chemical emissions from certain facilities. The final Toxic Chemical Release Form R and regulations for the 1987 reporting year were published in the Federal Register on February 16, 1988 (53 FR 4500-4554). The list of toxic chemicals subject to reporting consisted initially of chemicals listed for similar reporting purposes by the States of New Jersey and Maryland. There are over 300 chemicals and 20 chemical categories on these lists.

The reporting requirement applies to owners and operators of facilities that have 10 or more full-time employees, that are in Standard Industrial Classification (SIC) codes 20 through 39 (i.e., manufacturing facilities) and that manufacture (including importing), process or otherwise use a listed toxic chemical in excess of specified threshold quantities. The following information is required on Form R:

- the name, location and type of business; public contact and phone no.
- chemical name and Chemical Abstracts Service Registry Number (CASRN);
- whether the chemical is manufactured (including importation), processed, or otherwise used and the general categories of use of the chemical;
- a range estimate (in pounds) of the maximum amounts of the toxic chemical present at the facility at any time during the calendar year;
- quantity of the chemical annually entering each medium air, land and water; underground injection
- off-site locations to which the facility transfers toxic chemicals in waste:
- waste treatment methods and efficiency;
- information on waste minimization:
- pollution prevention data (beginning with 1991 reports) and,
- a certification by a senior facility official that the report is complete and accurate.

#### **DESCRIPTION:**

The diskette includes selected data from the TRI reporting form. These are: the TRI facility identification number, the name, county, city, zip code and Standard Industrial Classification Code of the reporting facility; the parent company name, chemical name and Chemical Abstracts Service Registry Number, aggregate releases in pounds of the chemical to air, land, underground injection, water, and transfers to offsite disposal locations and publicly owned treatment works.

The 1988 and subsequent reporting years also include more information about the facility: the public contact and phone number, longitude and latitude, the state and county FIPS (Federal Information Processing Standards) code, and various EPA-assigned waste permitting identification numbers.

High density 5.25 and 3.50 inch diskettes are available in the Lotus 1-2-3 (version 2.0), dBASE III PLUS, and ASCII for DOS microcomputers and Excel (version 2.1) for the Macintosh.

#### **DESCRIPTION:**

The fiche contains the complete TRI for the specified reporting year. Twelve indices help you to locate specific reports submitted by industrial facilities. You can look up: the name, city, county and zip code of the reporting facility, the chemical substances, name of publicly owned treatment works and off-site disposal facilities, and amounts in pounds of chemicals released to specific environmental media. A user guide, a list of Section 313 regulated chemicals and the Standard Industrial Classification codes of industries that are required to comply with the law, and a directory of EPA and State TRI contacts are included in the introduction of the fiche.

#### **DESCRIPTION:**

Reporting facilities are identified by: facility name, address, city, state, zip code, Standard Industrial Classification Code, Dun and Bradstreet number, parent company name and Dun and Bradstreet number, the public contact and phone number, and the TRI facility identification number. Additionally, the 1988 tape also includes the reporting year, facility county, region, and state FIPS (Federal Information Processing Standard).

Focus is on reporting requirements, changes from previous year's requirements, State summaries, total releases and transfers of TRI chemicals by media, geographic distribution of TRI releases and transfers, industrial patterns of releases and transfers, the interstate and intrastate transport of TRI wastes, chemicals with the largest releases and transfers, waste treatment and minimization, and other analyses. Maps, charts and tables are presented.

The Toxic Release Inventory (TRI) is a component file of NLM's TOXNET system. Utilizing a free text search capability, boolean logic, a powerful and flexible command language and a variety of online user assistance features, TOXNET offers state-of-the-art user-friendly searching. Online and offline printing of entire or specific portions of records is available, as is a variety of customized print options. Special TRI features allow sorting and numerical manipulation of data. A menu-driven search package also allows novice users or individuals with limited computer skills to search TRI efficiently.

Electronic Mail: Participants can communicate with one another through computer generated mail.

Documents: Can be exchanged and reviewed by participants.

Database Services: 1987-1990 TRI data, health facts on each chemical, cross-links to federal districts, a listing of all civil cases brought by the U.S.EPA, and a portion of the 1990 Census.

Charges for the Federal Bulletin Board are based on the size of the file downloaded or displayed on the screen. The minimum charge is \$2 per file and applies to files up to 50 Kilobytes (50KB). Prices increase in dollar increments, with a full megabyte (1 MB) file costing \$21. The average file price for currently available material is \$6 to \$7. The price for transferring a file is clearly shown on the BBS and daily charges will be reported on your monthly Deposit Account statement. Users are responsible for their own telecommunication charges.
