IN THIS INTERVIEW, MR. JEAN-MARIE BOUCHARD OF THE FRENCH MINISTRY FOR THE QUALITY OF LIFE'S INDUSTRIAL ENVIRONMENT SERVICE DISCUSSES THE EVOLUTION FROM THE POLICY OF GOVERNMENT REGULATION OF POLLUTION ABATEMENT TO THE CURRENT POLICY OF NEGOTIATING INDIVIDUAL INDUSTRIAL SECTOR CONTRACTS. THE FORMER REGULATORY POLICIES WERE BASED ON THE 1917 LAW ON CLASSIFIED ESTABLISHMENTS. POLLUTING INDUSTRIES, HOWEVER, OFTEN ENCOUNTERED DIFFICULTIES IN COMPLYING WITH THESE REGULATIONS DUE TO EITHER INADEQUATE CAPITAL OR TECHNOLOGY. THE DEVELOPMENT OF CONTRACTUAL AGREEMENTS BETWEEN THE GOVERNMENT AND INDIVIDUAL SECTORS OF THE INDUSTRIES HAS LED TO THE NEGOTIATION OF SPECIFIC ABATEMENT OBJECTIVES WITH RECIPROCAL GOVERNMENT OBLIGATIONS IN PROVIDING FINANCIAL ASSISTANCE. FIVE SUCH CONCLUDED CONTRACTS ARE DETAILED IN THE INTERVIEW.

THIS ARTICLE REPORTS THAT THE JOINT ENFORCEMENT CAMPAIGN OF THE GENERAL TRANSIT DIRECTORATE OF MEXICO CITY AND THE MEXICAN SUBSECRETARIAT FOR ENVIRONMENTAL IMPROVEMENT TO MONITOR, DETAIN AND FINE EXCESSIVELY-POLLUTING VEHICLES IN THE CITY HAS BEEN POSTPONED IN FAVOR OF A PUBLIC CAMPAIGN TO ELICIT VOLUNTARY COOPERATION FROM MOTORISTS IN CORRECTING DEFECTS IN EXHAUST SYSTEMS WHICH CAUSE AIR POLLUTION. AS ORIGINALLY PLANNED, 25 TEAMS, EACH CONSISTING OF TWO POLICEWOMEN AND AN INSPECTOR OF THE SUBSECRETARIAT, WILL BEGIN PATROLLING THE CITY REQUESTING VOLUNTARY CORRECTIVE MEASURES BE TAKEN BY DRIVERS WHOSE VEHICLES ARE DETECTED POLLUTING THE ATMOSPHERE TO AN EXCESSIVE DEGREE. THE SERVICES OF A POLLUTION MEASURING AND DIAGNOSTIC STATION WILL BE MADE AVAILABLE TO DETAINED MOTORISTS TO DETERMINE THE EXTENT TO WHICH THEIR VEHICLES ARE POLLUTING THE AIR. THE ENVIRONMENTAL PATROLS WILL OPERATE AT STRATEGIC POINTS THROUGHOUT THE CITY IN THIS MANNER. IT IS NOT KNOWN WHEN OR IF MORE STRINGENT ENFORCEMENT MEASURES WILL BE TAKEN.

THIS FRAMEWORK LAW, PROMULGATED BY THE BELGIAN KING ON JULY 12, 1973, PROVIDES FOR THE PROTECTION OF NATURE AND THE SAFEGUARD OF THE NATURAL ENVIRONMENT THROUGH THE CREATION OF NATURAL RESERVES, FOREST RESERVES, OR NATURAL PARKS. THE LAW SPECIFIES THE SPECIAL CHARACTERISTICS OF EACH TYPE OF RESERVE AND DESIGNATES A SERIES OF ACTIVITIES, SUCH AS HUNTING AND DEFORESTATION, WHICH ARE TO BE PROHIBITED IN SUCH AREAS. THE MINISTRY OF AGRICULTURE, IN ACCORDANCE WITH MANAGERIAL FUNCTIONS DELEGATED TO IT BY THE KING, IS HELD RESPONSIBLE FOR THE ISSUANCE OF ALL NECESSARY IMPLEMENTING REGULATIONS. THE LAW ALSO PROVIDES FOR THE ESTABLISHMENT OF AN ADVISORY SUPERIOR COUNCIL FOR THE CONSERVATION OF NATURE TO ASSIST THE MINISTRY IN THE PERFORMANCE OF ITS FUNCTIONS.

THIS IS CONTRASTED TO THE SITUATION IN GREAT BRITAIN, WHERE A TRADITION OF POLLUTION CONTROL LEGISLATION AND LARGE INVESTMENTS HAVE SUCCEEDED IN PRODUCING EFFECTIVE RESULTS. THE PROBLEMS GREAT BRITAIN FACES UPON ENTERING THE THIRD STAGE OF POLLUTION INVOLVE THE EVER-INCREASING DEMAND FOR INDUSTRIAL AND PER CAPITA USE OF WATER.
