The Clean Air Scientific Advisory Committee (CASAC) Technical Subcommittee on Fine Particle Monitoring, met on April 18-19, 2000 in Research Triangle Park, NC to conduct a Consultation with staff from the Office of Air and Radiation (OAR), Office of Air Quality Planning and Standards (OAQPS) on thermal carbon analysis.

The SAB has developed the consultation as a mechanism to advise the Agency on technical issues that should be considered in the development of regulations, guidelines, or technical guidance before the Agency has taken a position. A consultation is conducted under the normal requirements of the Federal Advisory Committee Act, which include advance notice of the public meeting in the Federal Register.
