What is *Enviro\$ense*?

- *Enviro\$ense* is a free environmental document exchange system that provides users with enforcement and compliance assistance information, pollution prevention (P2) solutions, and innovative technology insights.
- *Enviro\$ense* contains information from a wide array of organizations including federal, state, and local agencies, non-governmental organizations, manufacturers, suppliers, and researchers.
- *Enviro\$ense* is a single site for those who seek cleaner materials and chemicals, and enforcement and compliance information. The site provides data which may help businesses, regulatory agencies, and others meet environmental requirements.

- **EPA-Funded Research Projects, Grants, and Fellowships.** Easily access interagency research funding opportunities as well as past and present research projects and programs through the National Center for Environmental Research and Quality Assurance.
- **P2 Case Studies.** See how companies successfully implemented pollution prevention measures, improved productivity, and saved money.

P2 State & Federal Government, and International Cooperative (found at: www.epa.gov/envirosense/cooperative)

- Explore the P2 Cooperative, a virtual network of partnering web sites designed to support exchange of technical and program information from a single website. The P2 Cooperative supports preset topical and user-defined searches which access all of the partners' P2 collections.

News, Resources, Contacts, and Funding

- **Vendor Information.** Research vendor information from the extensive Illinois Waste Management Research Center's TechInfo and VendInfo databases. Use the National Pollution Prevention Roundtable's "yellow pages" to find P2 and regulatory contacts.

DOD/Joint Services

- Look at DoD's extensive P2 programs and information resources. Access model P2 Plans. Search the Joint Service P2 Library database.

Enforcement and Compliance Assurance (found at: www.epa.gov/envirosense/oeca)

Keep current with the latest policy and guidance documents, new regulations, and compliance assistance information available through compliance assistance centers, industry sector notebooks, databases, and other resources.

- **Federal Facilities Environmental Leadership Exchange (FFLEX).** Obtain pollution prevention, technical assistance, regulatory enforcement, and compliance information for federal facilities. Download such documents as the environmental audit protocol, policy and technical guidance for environmental management reviews, and federal agency environmental roundtable news.
- **Supplemental Environmental Projects (SEPs).** SEPs are environmentally beneficial settlement projects, which, while not required by law, are considered when establishing the final penalty paid by the defendant. Find out how some companies have used pollution prevention SEPs to settle cases and improve their prospects for future compliance.
- **Sector Notebooks.** Access and download comprehensive data on manufacturing processes, regulations, pollutant release data, innovative programs, compliance history, P2 opportunities, and information. Over 25 sectors are covered including Air and Ground Transportation, Dry Cleaning, Printing, Electronics & Computers, Organic & Inorganic Chemicals, Petroleum, Rubber & Plastics, Pharmaceuticals, Metal Mining, and Textiles.

Solvent Substitution Data Systems (found at: www.epa.gov/envirosense/ssds/ssds.html)

The Solvent Umbrella. Examine an integrated set of databases which allow you to access solvent alternative information, including: EPA's Solvent Alternatives Guide (SAGE), Idaho National Environmental Engineering Laboratory's Hazardous Solvent Substitution Data System (HSSDS), Solvent Handbook Data System (SHDS), Ozone Depleting Substance (ODS), and Solvent Alternatives Databases.
